Grades 7-12 ACCESS Virtual Learning:

Per our OCS grading manual, students earn credit for a course by scoring a 2 or higher for their final course score. A score of 2 converts to a 70% on a traditional 1-100 grading scale. Beginning in the 2023-2024 school year, ACCESS students will have to earn a 70% or higher to earn credit for a course. ACCESS courses are taught by Alabama certified teachers, not Oxford City Schools' teachers. Oxford City Schools must adhere to the guidelines set forth by ACCESS. Students will be dropped from courses for inactivity. Students MUST be actively engaged in the online environment to be successful.
